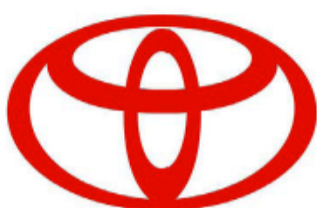
FROM THE EDITOR...

THE TOYOTA RECALL DUE TO A DEFECTIVE ACCELERATOR PEDAL

**IF YOU WERE INJURED, DO
NOT GIVE YOUR TOYOTA

If you or someone you love was seriously injured from a Toyota automobile accelerator pedal, your first inclination is to give the product to Toyota or the dealer so that they can see there is a problem. **DO NOT DO THIS!**

Won't Toyota know that it was their fault and just compensate you for you injuries? While Toyota may know that it was their fault, if our past experience is any prediction of the future, Toyota will do all it can to claim that the crash that caused the serious injury was your fault - not theirs.
